2018 Global Forum Latin America and the Caribbean was a grand success with the participation of dozens of interested audience members, representatives from the private and public sector, journalists and members of the media as well as academics from New York City and around the world. Over two days, presentations, panel discussions and keynote speeches from some of the region's top experts and leaders engaged in thought-provoking debate and discussion that will surely fuel some conversation about the role and challenges faced by Latin America and the Caribbean in the year to come.

GFDD would like to express gratitude to the panelists and participants who made the Forum possible. A special thanks is also given to the volunteers and collaborators who dedicated their time and assistance to the event.

The organizing committee is sure that this conference contributes to the discussion and exchange of ideas concerning the social, economic and democratic growth of the region. It looks forward to continuing these efforts at the 2019 Global Forum Latin America and the Caribbean.



More than 30 international experts, including Heads of State, Ministers of Foreign Relations and senior representatives of regional organizations and think tanks discussed their ideas on the present and future of the region of Latin America and the Caribbean on September 25-27, 2018 at the First Annual Global Forum Latin America and the Caribbean in New York City.

The First Global Forum was held at the Union League Club of Manhattan and was organized by GFDD/Funglode. Other event organizers included the International Institute for Democracy and Electoral Assistance (IDEA Internacional), the Institute of Latin American Studies – Columbia University and the Economic Commission for Latin America and the Caribbean (ECLAC).

The international event was led by GFDD President and former President of the Dominican Republic, Dr. Leonel Fernández.

The Forum brought together the foremost think-tanks dedicated to the study of the region's dynamics, in order to launch a dialogue and present proposals that would encourage development with equity. Among the most renowned panelists and guests were Organization of American States (OAS) General Secretary Luis Almagro; Former Presidents Vinicio Cerezo from Guatemala and Carlos Mesa from Bolivia; Isabel de Saint Malo de Alvarado, the Vice President of Panama and Jorge Castañeda, the former Mexican Foreign Minister.

Over the course of two days, these high-level panelists and other experts held conversations and analyzed the role of Latin America and the Caribbean as well as implication and challenges for the region on the world stage. The Forum provided a pluralist platform for debate and the exchange of ideas.







"Global norms have not prevented the recurrence of all kinds of crises, all kinds of conflicts that have challenged and continue to challenge the democratic institution and processes in lots of countries. So, we have this declaration of universal rights and most of the members states of the United Nations are committed to the declaration but in terms of the implementation it differs from case to case. [There is an] increasing lack of agreement indeed at a global level of the meaning for instance of fundamental rights, like democratic rights."

#### Global Forum Experts Tackle Economics, Elections and the Region's Role in the International Arena

September 26, New York City

The official program of the Global Forum on Latin America and the Caribbean began on Wednesday, September 26, a day filled with panel discussions and speeches concerning topics such as the socioeconomic perspectives for Latin America and the Caribbean; the international economic scenario; the super-cycle Latin American electoral calendar for 2018 and the region's position in the global arena.

On this day, Executive Secretary of ECLAC, Alicia Bárcena delivered her keynote on "Economic Perspectives of Latin America and the Caribbean," which highlighted the financial situation in the region and pointed to various macro-economic concerns. Following the Secretary's presentation were two panel discussions led by economists from the World Bank and the United Nations as well as other leading think-tanks and organizations in the field of economics and finance.

Also, on Wednesday were two panels and a keynote address concerning democratic processes in the region. First, Mr. Zovatto highlighted concerns over democracy and corruption in Latin America and the Caribbean in a speech entitled "Electoral Super Cycle 2018." Afterwards, leaders from top think-tanks, institutions of higher learning and regional bodies reflected on and debated past and future electoral outcomes and the importance of regional political institutions.

To close the day, Dr. Fernández gave a speech on the political panorama of Latin America and the Caribbean and demonstrated how the region's current political situation is tied to the 2008 financial crisis. He encouraged the creation of a consultation mechanism to coordinate policies of the region as a whole. According to Dr. Fernández, this mechanism would help Latin America and Caribbean be much more effective in strengthening its presence at the international level.

"Nowhere in the world is there a region where there are so many institutions working towards the same thing," explained Fernández. The President was referring to the multiplicity of efforts that have been carried out to integrate the Latin America and Caribbean region without reaching important advancements in integration.

Dr. Fernández' dissertation was commented on by a panel of experts made up of distinguished political scientists Iván C. Rebolledo, Shannon O'Neil and Thomas A. Shannon. All touched upon the key issues presented by Dr. Fernández and expressed their own points of view regarding the current situation faced by Latin America and the Caribbean regarding a functional integration system and its relationship to the international community.

September 27, New York City

On the final day of the conference, the focus was the value of democratic and regional instruments to ensure the promotion of democracy.

In the morning a panel of experts, including Secretary General of the OAS Luis Almagro, Yves Leterme, Massimo Tommasoli, Thomas Garret, and Christopher Sabatini touched upon issues regarding the current regional integration institutions in Latin America and the Caribbean in a conversation entitled "the Value of the International and Regional Democratic Instruments to Guarantee Sustainable Democracies."

Latin America continues to lack an effective overall mechanism that will guarantee the sustainability of democracy, an element that constitutes a challenge to the region that it must overcome in the short-term, the panelists agreed.

In the afternoon General Secretary Almagro gave special remarks in which he encouraged the strengthening of democracy in the region. During his intervention, titled "Perspectives on Democracy in Latin America and the Caribbean," the OAS Secretary General encouraged the people of Latin America and the Caribbean to work together to build a solid and effective democratic system that will leave no space for the entry of authoritarian governments.

"We need less fear and more energy to face the dictatorships in the region," stated Almagro. "We have sent clear messages that we want a hemisphere free of crimes against humanity," he added.

The General Secretary then shared the stage with a high-level panel featuring former Presidents Leonel Fernández of the Dominican Republic; Vinicio Cerezo from Guatemala and Carlos Mesa from Bolivia. Also participating were Isabel de Saint Malo de Alvarado, the Vice President of Panama and Jorge Castañeda, the former Mexican Foreign Minister. Dr. Fernández and the group of leaders discussed challenges to democracy and the region's human rights crises.

The world leaders concluded that democratic norms ought to be strengthened, since dictatorial tendencies, particularly in places like Nicaragua and Venezuela, are threatening the region's status as a beacon for democracy.























In close association with the United Nations and other organizations, GFDD organizes regular interviews with ambassadors, think-tank experts and multilateral institutions representatives in an effort to spread news and understanding of global issues and work of different international bodies.

#### The OAS in Regional Democratic Processes

April 19, Washington, DC

Luis Almagro Lemes - Secretary General of the Organization of American States

In the first edition of the 2018 GFDD Global Roundtables, GFDD invited Luis Almagro Lemes, the Secretary General of

the Organization of American States (OAS) to the organization's offices for a discussion about the most pressing issues facing Latin America. The OAS Secretary General was interviewed by GFDD's Socio-Economic Development Program Manager, María Victoria Abreu, who asked the leader several questions about the role of the OAS in regional democratic processes including its electoral observation missions as well as about new institutional challenges for the OAS and the then upcoming General Assembly that was to be held in the Washington, DC in June 2018. When asked about the OAS' slogan, "more rights for more people" Almagro noted that the phrase represents an important approach since Latin America and the Caribbean is the most unequal continent in the world. For that reason, not all of its citizens have the same opportunity to access their rights.

#### **DECO Supports Electoral Processes Throughout the Hemisphere**

September 4, Washington, DC

In a September edition of the Global Roundtables, Semiramis de Miranda, GFDD Projects and ICT Director, and diplomat and GFDD contributor Angie Martinez received Gerardo de Icaza, Director of the Department of

Electoral Cooperation and Observation (DECO) at the OAS, at the GFDD offices in Washington, DC. In an interview with Martinez, de Icaza spoke about the role of the OAS in promoting and ensuring democratic norms and systems in the Western Hemisphere. De Icaza also explained the goals of DECO in the electoral observations that it facilitates, which include: ensuring that underrepresented populations, like women and indigenous communities, are able to vote; guaranteeing that electoral processes are fair and accurate and finally, making certain that elections are clean of abuse, bribes and other forms of fraudulent activity. The Director of DECO noted that the OAS missions have been quite effective in ensuring and promoting democratic processes throughout the region.

### ECLAC Celebrates 70 Years of Promoting Sustainable Development in Latin America and the Caribbean

November 8, Washington, DC

Inés Bustillo - Director of the Washington Office of ECLAC

The Director of the Washington Office of the Economic Commission for Latin America and the Caribbean (ECLAC), Inés Bustillo, visited the GFDD offices for an interview with diplomat Angie Martinez. The two spoke about ECLAC's mission as well as the challenges and advances made on social and economic development during the organization's 70-year history.





The Director of the ECLAC Washington Office noted some of the major challenges that ECLAC has faced. Most recently the impacts of globalization, including migratory flows and technological change, have caused major shocks. Dr. Bustillo also explained that while the region has advanced in terms of simple economic production, social, political and environmental development have not always grown at the same rate. Despite facing such hurdles, Dr. Bustillo remained optimistic, saying that regional integration and a demographic dividend will help Latin America prosper in the long-run.

#### Women Leadership at the OAS and Throughout in the Hemisphere

November 28, Washington, DC

Rita Hernández Bolaños – Ambassador, Permanent Representative of Costa Rica to the OAS

In the November edition of the Global Roundtables, GFDD welcomed the Ambassador, Permanent Representative of Costa Rica to the OAS, Rita Hernández Bolaños to the GFDD offices in Washington for a discussion with Angie Martinez. Among the



topics discussed were women leaders in politics and the future of the OAS. Hernández, one of only six female Permanent Representatives at the OAS, mentioned how, as a woman, it was challenging to move up in the field of diplomacy. The Ambassador noted the advances that had been made toward gender equality, but that work lay ahead. She highlighted the strong commitment to equality from Costa Rica's President, Carlos Alvarado, whose administration has equal representation of men and women leaders.

#### Peru Continues to Support Regional Frameworks on Democracy

December 7, Washington, DC

GFDD was honored to have the Ambassador, Permanent Representative of Peru to the OAS, Ana Rosa Valdivieso visit the Washington office for a December Global Roundtable interview with

Martinez. The two discussed Peru's work at the OAS as well as the country's leadership throughout the region. The Ambassador stressed that "Peru is a country committed to democracy and to human rights." She explained the significant role that Peru has played in encouraging peace in Venezuela and, more recently, in Nicaragua. The two chatted about the recent 8th Summit of the Americas, which was held in Lima, Peru in April 2018. She mentioned that the signing of the Lima Commitment, a regional agreement to fight corruption, was the greatest achievement of the meeting. Her country will continue to fight for the creation of regional frameworks on governance, human rights and democracy, said the Ambassador.

#### The Importance of Financial Capacity for Rural Women Stressed at 62nd Session of the Commission on the Status of Women

The NGO Committees on Financing for Development and GFDD/Funglode partened up to hold a panel discussion during the 62nd Session of the Commission on the Status of Women (CSW62). The event, titled "Economic Empowerment of Rural Women Through Access to Innovative Financing and Effective Partnerships," brought together a variety of experts who generated ample debate on the effectiveness of the financial services available to rural women in developing countries. Representatives from the NGO sector, a representative from the private sector and one from the UN organization highlighted the importance of strengthening the capacity of rural women to correctly save, borrow, insure and invest due to women's key role in the agricultural sector.



#### **GFDD** and International Colleagues Call for Financial Access to Reduce Global Poverty

#### April 26, New York

At a side event organized by the NGO Committee on Financing for Development at United Nations Headquarters in New York, GFDD/Funglode continued to promote financial inclusion for all. The event was meant to present the progress made and likely future challenges for financial inclusion strategies to reduce income equality, alleviate poverty and shrink the gender gap. Among the countries and organizations represented at the forum were Brazil, Nigeria, Puerto Rico and the United Nations. Yamile Eusebio, New York office director of GFDD, and UN intern Skyara Guridi represented the institution and supported the organization of the side event.



#### Side and Special Events at the High-Level Political Forum on Sustainable Development 2018 (HLPF)

July 9-18, New York

GFDD participated in several intergovernmental and side & special events organized within the framework of the High-Level Political Forum on Sustainable Development 2018 (HLPF). The HLPF 2018 was an opportunity to not only assess the progress of the SDGs and their implementation, but also to address climate change. The issues discussed included going Carbon-Neutral, getting young people involved in the implementation of the 2030 Agenda and using technology to deliver the SDGs.

Collaboration with the United Nations

#### The United Nations Office for South-South Cooperation Seeks Collaboration with GFDD/Funglode

#### July 26, New York

GFDD/Funglode representatives, Dr. Leonel Fernández and Natasha Despotovic, met with Jorge Chediek, the Director of the United Nations Office for South-South Cooperation (UNOSSC), a UN body established to promote, coordinate and support South-South and triangular cooperation globally and within the United Nations system. Throughout their discussion the two groups found common ground and opportunities to work collaboratively. **UNOSSC invited GFDD/Funglode to participate in a number of the group's** initiatives including: NEST, a UNOSSC group of think tanks which exchanges knowledge and expertise among its members; South-South Cooperation (SSC) events, including the then upcoming Delhi Conference on South-South and Triangular Cooperation; the UNOSSC South-South Cooperation on Peace and Development program; UNOSSC youth leadership program Youth for South (Y4S) and UNOSŠC's publication initiative called South-South in Action. At the end of the discussion, the two agreed to meet again in September at which point they planned to sign a Memorandum of Understanding (MOU) regarding the topics discussed, although the work between the organizations got under way even before the agreement was to be signed.









#### United Nations Day for South-South Cooperation Marks the 40th Anniversary of BAPA

#### September 12, New York

A special celebration of United Nations Day for South-South Cooperation took place at the UN headquarters in New York. # 400 Latin American and Caribbean Students Tackle Global Issues in the First Annual NYMULAC 2018



## April 1-5, New York

The Dominican Association of the United Nations (ANU-RD) and GFDD/Funglode, along with the Mexican GlobalMuners civil association, opened the first annual New York Model United Nations Conference for Latin American and the Caribbean (NYMULAC) with the participation of more than 300 young students from the Dominican Republic and some 100 peers from other Latin American and Caribbean nations. # Peace, Prosperity and Ecological Balance Must Prevail

# January 10, Washington, DC

In a presentation entitled "A World in Transition: Geopolitical Perspective in a Time of Change," delivered in front of Inter-American Defense College authorities, Ambassadors to the OAS, heads of delegation and leaders of the Inter-American Defense Board, faculty and master's degree students at that institution, GFDD President Dr. Leonel Fernández began his 2018 international endeavors. In the speech Dr. Fernández touched upon several topics relevant to development and, in particular, security issues in Latin America. Fernández discussed the interactions between the United States



and Latin America, which gained considerable momentum after the rapprochement with Cuba, but also highlighted the gap in military spending of the United States and the rest of the countries in the Americas. The former president of the Dominican Republic called for the establishment of a new world order that is aligned with the main needs, concerns and aspirations of the inhabitants of the planet. The speech was given as part of a Conference that took place at the Inter-American Defense College in Washington.



# National University General San Martín (UNSAM) Awards Dr. Leonel Fernández with Honorary Degree

March 15, Buenos Aires, Argentina

Dr. Fernández laid out policy recommendations at the annual meeting of the Academic Council on the United Nations System (ACUNS), an event that was held at LUISS University in Rome, Italy, under the

theme "Human Rights, Migration, and Global Governance." Regarding the event's focus on immigration, President Fernández advocated for the establishment of national regulations that guarantee both state sovereignty and the rights of migrating peoples. He stressed the importance of immigration policies that respond to objective and reliable data and not to rhetorical discourse bereft of evidence-based information. At the meeting the former Dominican president shared the stage with an audience made up of academics from LUISS University, members of ACUNS, politicians, diplomats and other important international figures.

# July 31, Orlando, FL

# **President Encourages the Trajectory of Young Diplomats at EU-LAC Foundation Meeting**

# September 10, Panama City, Panama

The First Young Diplomats of Central America and the European Union Program featured the leadership of President Fernández. The program, organized by the EU-LAC Foundation, of which Dr. Fernández is the President. was attended by representatives from nearly twenty countries in the Americas and Europe. The meeting's theme was "facilitating a joint look at shared challenges," and intended to promote confidence and mutual understanding for bi-regional relations between Europe and Latin America. The activity took place in the facilities of the Diplomatic and Consular Academy of Panama's Foreign Relations Ministry and featured the participation of young diplomats from the Dominican Republic, Panama, Guatemala, Honduras, El Salvador, Costa Rica, Mexico, Haiti, Portugal, Italy Lithuania, Romania, Spain, Slovakia, France, Bulgaria and Finland. Over the course of his 24-hour stay in Panama, Fernández also held separate work meetings with the president of the country, Juan Carlos Varela and the vice-president, Isabel Saint Malo, with whom he spoke about topics discussed at the Young Diplomats event as well as others on the global agenda.





## President Fernández Provides Leadership, Insight at the First Annual Global Forum Latin America and the Caribbean 2018, a New Platform for Debate and the Exchange of Ideas

## September 25, 26 and 27, New York

Dr. Fernández headed the activities at the Global Forum on Latin America and the Caribbean 2018, a meeting of more than 30 international experts, Heads of State, Ministers of Foreign Relations and senior representatives from regional organizations and think-tanks held conversations and analyzed the role of Latin America and the Caribbean on the world stage.

Dr. Fernández started the ceremonies on September 25 with a speech welcoming the special guests and panelists who presented at the 2018 Global Forum on Latin America and the Caribbean. During this intervention, the former Head of State spoke about democracy in the region, mentioning that the Dominican Republic played an important role in promoting democratization of the region. The Dominican Republic was the first country to establish a democratic system of governance four decades ago, said Fernández.

Also, on Wednesday, September 26, the president delivered a keynote speech and on Thursday, September 27 he participated in a forum with regional leaders. The keynote delivered on Wednesday encouraged the creation of a mechanism that would coordinate the policies related to the region at the international level. There are currently too many integration mechanisms that have been created in the Latin American and Caribbean regions, said the president. He explained that these institutions are currently confronting serious internal problems that have weakened their functions.

"Nowhere in the world is there a region where there are so many institutions working towards the same thing," explained Fernández when referring to the multiplicity of efforts that have been carried out to integrate the Latin America and Caribbean regions. In a panel discussion the next day, Dr. Fernández shared the stage with Organization of American States General Secretary Luis Almagro, who delivered a keynote address about democracy prior to the conversation. In response to the Secretary's statements, former President Fernández stated that the fundamental challenge faced by democracy in the region is to full satisfy the expectations of the people. He indicated that the so-called "lost decade" of the 20th century was provoked because the regional democracies were not prepared to satisfy the needs of their citizens.

The two-day-long conference was a grand success, which featured the participation of hundreds of interested audience members, representatives from the private and public sector, journalists and members of the media and academics from New York and around the world. Dr. Fernández leadership was integral in what was the first of many successful Global Forum Latin America and the Caribbean.

# **Dr. Fernández Accepts t**he Nomination of President to the World Federation of United Nations Associations

# October 21, Punta Cana, DR

President Fernández was elected President of the World Federation of United Nations Associations (WFUNA) during the 42nd WFUNA Plenary Assembly at the Dreams Palm Beach Punta Cana Hotel in Punta Cana, Dominican Republic. The international event was led by Fernández, alongside the Secretary General of WFUNA, Bonian Golmohammadi, and featured the participation of delegations from 40 countries and five continents. Upon accepting the position, the former president said he hoped that in the next years the United Nations Associations, through WFUNA, could continue to have a significant impact in the respective countries and, at the same time, add value to the United Nations' commitments to peace, security, prosperity and wellbeing of all the countries in the world.

During the event, workshops, high-level panel discussions and keynote addresses all related to the United Nations' (UN) current geopolitical orientations and reforms were carried out. The central theme of the event was "Peace, Justice and Strong Institutions," within the framework of the UN Sustainable Development Goals (SDGs). The 42nd WFUNA Plenary Assembly was organized by GFDD's sister organization in the Dominican Republic, Funglode, and the Dominican Republic United Nations Association (ANU-RD, for its initials in Spanish) jointly with WFUNA.









# The President Stresses Issues of Dominican Citizenship at the Annual Miami Book Fair

November 21, Miami, FL

During a launch of his book "Años de avances. Escritos de Teoría y Acción" at the Miami Book Fair, Dr. Fernández took the opportunity to speak about the right of citizenship in the Dominican Republic. In a keynote speech the former President of the DR warned that if the Dominican Republic were to grant citizenship to all those born in its territory, the

country would eventually lose its national identity. "When we set forth the right of citizenship, it's not a racist, xenophobic nor exclusive ideology; what we are talking about is the survival of the country and the identity of the Dominican Republic," he said. The GFDD President made the comments in response to recent comparisons between the United States' policy of *jus solis*, in which citizenship is granted to all people born in the country's territory, and the policy of the Dominican Republic. The president gave the speech alongside a Dominican senator, José Rafael Vargas, and many interested book readers.



# Head of OAS Electoral Observation Mission in Mexico, President Fernández, Reports that "Election day was characterized by a peaceful process in most states"

# December 3, Washington, DC

Alongside the Secretary General of the OAS, Luis Almagro, and in front of the OAS Permanent Council, the former President of the Dominican Republic presented a final report on electoral processes in Mexico. The report's release came months after President Fernández had served as the Chief of the OAS Foreign Visitors Mission to the Elections in Mexico that accompanied the federal and local electoral processes in that country on July 1, 2018. During the December meeting, Dr. Fernández highlighted important observations and made several recommendations to the OAS Permanent Council. In his statement, Fernández highlighted that "Mexico has defined a robust legal framework, and its execution has been effectively accompanied by the actions carried out by various electoral institutions." He also mentioned that, while the elections were generally free and fair, there were instances of violence in certain Mexican states. Following the President's remarks, several OAS Permanent Representatives offered comments of their own, highlighting the importance of ensuring solid electoral processes throughout Latin America and the Caribbean.

# "How Can We Find Long-lasting and Tangible Solutions for the NGO sector?" Asks GFDD Research Fellow

February 15, Washington

2015 GFDD Research Fellow Megan D. Beddow showcased her research on the role and importance of Non-Governmental Organizations in the Dominican Republic during the release of her book "Fundamentals of the Dominican Voluntary Sector," at the UN Church Center. The fellow's main goal was to analyze the external environmental factors and internal organizational characteristics that shape the NGOs of the Dominican Republic while illustrating the classic evolution of the voluntary sector in a developing country. Among the insightful points made in her research, Ms. Beddow stresses the need to consider the following questions: What do NGOs in the Dominican Republic really need? How are we going to find long-lasting and tangible solutions? How can we collect and study successful practices that could help us to achieve our mission?

The introduction of the book release was delivered by Mr. Liberato C. Bautista, Assistant General Secretary for UN and International Affairs of the General Board of Church and Society (GBCS) of The United Methodist Church and former president of the Conference of NGO (CoNGO). Mr. Bautista qualified Ms. Beddows report as a crucial read, not only for scholars in academia, but also for grassroots practitioners who have the need for clear and accessible guidelines.

Mr. Severin Carminat, Program Officer with Alianza ONG, shared the improvements and accomplishments of the grassroots organizations in the Dominican Republic. Furthermore, he pointed out that Ms. Beddow's research reflected the Dominican civil society's strongest characteristic: its capacity to work united despite its broad level of diversity.

Megan Beddow is an academic from Florida and an expert in not-for-profit organizations. She has more than 10 years' experience in designing programs and management projects in the U.S., Mexico and Chile. She participated in the Fellows Program between June and August 2015.

Beddow has a Bachelor of Arts in Mathematics, Sociology and Spanish from Florida Southern College, a master's in Public Affairs and has specialized in the international management of not-for-profit organizations. She also has a master's in Caribbean and Latin American Studies from the University of Indiana.







# Research Fellow Argues that "Climate Change Must be a Government Priority"

# August 7, Santo Domingo

The Dominican Republic must, in the short-term, understand the Intended Nationally Determined Contributions (INDCs) – a U.N. initiative - to comply with the Paris Agreement and incorporate the accord's mandates to the country's National Strategic Development Plan and the Evaluations of Environmental Impact.

Attorney and doctoral candidate Sergio Muñoz Morales, from the University of Barcelona, presented this and other important conclusions based on his GFDD-published study titled "Legal, Political and Social Reflections of the Dominican Environmental Structure" at Funglode headquarters in Santo Domingo.

After explaining the methodology used in the research project and summarizing the content of his findings, Muñoz Morales shared the study's overall conclusions. During keynote remarks he stressed that "it is necessary to encourage a dialogue on the EIA and Climate Change laws, as well as the unification of concepts, such as local environmental management, complying with international agreements, and an evaluation strategy on natural resources."

Omar Ramírez, the director of GFDD/Funglode's Center for Environmental Studies and Climate Change, introduced Morales Muñoz and commended the research the Spanish expert had carried out. Yamile Eusebio, director of the GFDD office in New York, highlighted the efforts carried out by the institution to support high-quality research and studies that will benefit the Dominican Republic.

The event was organized in coordination with the Global Institutes of Higher Studies in Social Sciences whose rector, Marcos Villamán, also spoke on the excellent research performed by Morales Muñoz.

The GFDD Fellow's research is part of Muñoz Morales doctoral thesis at the University of Barcelona, titled "The Evaluation of Environmental Impact as a Management Tool of Environmental Risks and the Fight Against Climate Change: A Comparative Study on the Spanish and Dominican Legal Regimes." As a doctoral candidate at the University of Barcelona his research focus includes evaluating the environmental impact on societies of sustainable development and climate change by comparing Spanish and Dominican legislation. His goal is to introduce ideas that will lead to a legislative discussion on the modification of Dominican environmental laws, strengthening resilience based on the environmental structure of Dominican society and improving the overall quality of life in the Dominican Republic.

# Another Enlightening Presentation from GFDD Fellow Megan D. Beddow

# August 10, Santo Domingo

It is necessary to invest in training, simplify processes and establish mechanisms of responsibilities in order to contribute to the development of a volunteer movement in the Dominican Republic, explained expert Megan D. Beddow during the GFDD Fellow's second presentation of the year for her study, *The Fundamentals of the Dominican Voluntary Sector.* 

During the August presentation, carried out before a crowd in Funglode headquarters in Santo Domingo, Beddow expanded on her earlier findings. The researcher mentioned the many advantages that the NGO sector in the DR has including strong constitutional support and statutes that encourage the registration of volunteer sector organizations. She also highlighted the existence of an active civil society; strong economic growth; the Dominican Republic's advantageous geopolitical position; religious traditions and a strong international agenda that the DR shares with many of the world's leading countries

Beddow also brought up some of the main threats facing the volunteer sector. Among them were the complexities of the registry process; economic inequality; the limited promotion of informal and local organizations; cronyism, corruption and public mistrust, as well as the centralization of power in Santo Domingo.

"In the Dominican Republic the institutional weaknesses, economic and social inequalities, and the lack of confidence in the political leadership are factors the significantly reduce the benefits of a civil society and the human development needed for an emerging and strong volunteer system," said the GFDD Fellow.

Liberato Bautista, president of the Conference on NGOs (CoNGO), was once again present and explained that Beddow, importantly, recognizes the lack of formal academic research on this complex network of organizations. Bautista commented on the importance of the private sector in the development of volunteerism.

"This is excellent reading material in respect to the relationship that can exist between a local NGO and an international NGO," said Bautista.





#### The History of the Dominican Evangelical Churches is Grouped Together, Despite Differences Between Denominations

#### November 27, Santo Domingo

The history of the Evangelical Church in the Dominican Republic reflects the popular understanding of a unified identity among evangelical Christians, despite many differences among their beliefs and practices, argues Doctor of History Christina Davidson in her publication, *Analysis of Evangelical Christianity in the Dominican Republic*. This conclusion and more were formally presented on Tuesday, November 27 at la Fundación Global Democracia y Desarrollo (Funglode) headquarters in Santo Domingo as part of Davidson's research with the GFDD/Funglode Fellows Program.



Dr. Davidson then presented the main findings of her ten-month-long study. The researcher explained that the document provides a glance at two historical protestant churches with great presence in the DR: the African Methodist Episcopal Church and the Dominican Evangelical Church. Historical documents and interviews with church leaders were utilized to analyze how the institutions have changed and adapted to societal shifts overtime. According to the study's results, leaders of the two churches have adapted significantly to the growing influence of the protestant evangelical community. The churches have taken into consideration more ways to make their institutions more "Dominican" in terms of style and format, despite strong historical ties with the United States and a history of imperialism and racism among US missionaries.

A number of special guests were there to provide commentary following Dr. Davidson's presentation. Among them were political scientist and theologists and the project's research advisor, Marcos Villamán; Bishop Telesforo Isaac; Reverend Miguel A. Cancú and Reverend and lawyer Margarito Rodríguez.

# "No Country Can Afford to Ignore Higher Education" Argues Senior World Bank Economist, Maria Marta Ferreyra

GFDD hosted a timely presentation on successful education and labor markets, led by Maria Marta Ferreyra, Senior Economist, Office of the Regional Chief Economist for Latin America and the Caribbean of the World Bank, and author of "At a Crossroads. Ferreyra noted that we need to provide students, starting in high school, with more information of the different career paths to help them visualize themselves in not-so-popular choices such as industrial engineering and other STEM related careers with better net rates of return. Dr. Leonel Fernández, former president of the Dominican Republic and president of GFDD/Funglode, participated in the event via videoconference alongside local experts in Santo Domingo.

Ms. Marte's workshops also encourage family unity and integration through environmental activities. The workshops serve as a space for participants to learn how to make proper use of available resources, such as materials normally considered trash, which can be converted into useful resources for domestic and personal use.



# From Milk and Juice Packaging to Fish: How to Create from Waste Products

January 24, Santo Domingo, DR

The ReCrearte program, in coordination with the Fundación UnToque de Luz (Touch of Light Foundation), held an interesting workshop at the El Túnel School, in the Capotillo Sector, one the the most vulnerable areas in the country.

A diverse group of pre-teens and teenagers, 11 through 15, greeted ReCrearte's program manager, Lucia

Marte, who talked to them about the causes and consequences of water pollution, which was especially relevant because the school is located on the banks of the Isabela River. She also taught the children how to make fish figures by reusing the milk and juice cartons from their school breakfast.

Two of their teachers and a representative from the Un Toque de Luz Foundation were also at the activity. Professor Jacinta Castillo noted that the workshop was extremely valuable and appropriate for the reality in which the students live.



# Los Frailes Sector 2 Hosts ReCrearte Workshop

January 25, Los Frailes, DR

GFDD's ReCrearte program continued it full schedule of lectures and workshops in and around Santo Domingo. ReCrearte paid a visit to a group of women and girls in Los Frailes 2 where participants had a blast learning about recycling and reusing instead of tossing their trash.

The group, comprised of 13 people, began their workshop with an interesting lecture on the importance of taking care of Mother Earth and the resources she provides us.

Lucia Marte, ReCrearte program coordinator, initially focused on offering important information on how to avoid the accumulation of trash in the communities. In the second part of the activity, participants learned how to make bags and purses out of fabric that would otherwise have been discarded. This activity enables women to create innovative and unique designs out of blouses, pants and fabric they no longer use, rather than discarding it.

One participant, Lidia Vitorino, was pleased with the activity, especially reusing fabric from used clothing they would have otherwise thrown out.





# ReCrearte Closes January with Two Important Activities in Greater Santo Domingo Neighborhoods

GFDD's ReCrearte Program kept up a very active agenda during January that ended with two workshops held in two specific neighborhoods in the Greater Santo Domingo area, where it is important to encourage and emphasize environmentally-friendly measures through the initiative known as the 3Rs.

The Héctor J. Díaz Sports and Cultural Club, situated in the "Capotillo" neighborhood in northern Santo Domingo, was the venue where a group of adolescents gathered to learn creative projects by using recycled paper and plastic bottles. On January 25, 13 teenagers and four adults participated in these workshops where they expressed their commitment to put into practice the techniques learned by using the resources that are readily available to them in their specific communities. The group also learned how to put together a community bulletin board that will provide important information on various issues to the community.

The "Toque de Luz" (Touch of Light) Foundation, an important program partner, participated in the workshop organized in the "Capotillo" neighborhood.

Program coordinator Lucia Marte continued with her teaching agenda on January 28, this time at the "La Caleta" community, situated in the eastern section of Santo Domingo. Others who participated in the workshop were Mrs. Grecia Enrique, the Association of Women Carmen Delia Cedeño, and the "Las Mariposas" Group. The workshop was held at the FREMOPROCA offices, where some 35 community members learned how to recycle waste products in the creation of artistic works. Workshop participants learned to reuse egg cartons to make papier maché, and later use the paper to create decorative vases.

Participants explained that this kind of activity encourages personal growth, helps the environment, and opens the door to the possible generation of extra income for many of the participating families. Alexandra Rincón, a participant in the workshop help in "La Caleta," said that she enjoyed learning to make new things with materials she would have thrown out in the garbage.





# **ReCrearte Now in Punta Cana**

March 8, Punta Cana, DR

GFDD's ReCrearte Program celebrated International Women's Day by hosting an instructive fabric-recycling workshop that was held at the Hotel Dreams Palm Beach, in Punta Cana, the country's foremost tourism enclave.

Program coordinator Lucía Marte presented an instructive lecture to the 22 workshop participants (21 women and one man) on recycling and valuable techniques on how to reuse garments to create shopping bags made with fabric.

Ms. Mariela Cotes, a participant, stated that the workshop was very productive which provided her with the necessary information that will enable her to recycle fabric and make shopping bags that she will be able to use in her personal daily schedule.

ReCrearte coordinated the workshop with the support of Ms. Lorna Aquino and Green Love. The workshop is part of a series of activities scheduled by GFDD, in coordination with Green Love, to raise awareness among the general population on the importance of reusing available resources to create decorative ornaments and other useful objects.




#### Working Hand in Hand with the Dominican Embassy at the Taste of the World DC Festival

The young filmmakers stressed that the goal of their initiative is to expose the constant threats that females face and to help lower gender violence statistics in the Dominican Republic.

# "Cacú: Un cambio por la vida" Presented in Honor of World Turtle Day

# May 23, 24 and 28, New York

Three different New York audiences were spectators to the film *Cacú: Un cambio por la vida* during a week-long celebration of World Turtle Day. The showings were held at the United Nations Headquarters, Yonkers' Middle School and Salomé Ureña School in New York City. The 79-minute documentary, directed by Guatemalan/ Dominican photojournalist Marvin del Cid, features the revealing story of five fishermen from the underprivileged community of Manresa, situated in the southwest section of Santo Domingo,



who transitioned from being sea turtle nest predators to full-fledged conservationists. Each screening was followed by a dynamic and educational discussion with the film director, Marvin del Cid, and Dominican marine biologist, Omar Shamir Reynoso, who spoke on the making of the documentary and the importance of working to conserve the world's turtle population.

An enthusiastic audience packed Lincoln Center's Walter Reade Theatre to view the special presentation of the Dominican film La Barbería, Dominican film maker Waddys Jaquez' first feature film. The event included the



presence of the former President of the Dominican Republicand president of GFDD/Funglode, Dr. Leonel Fernández; Juan Marichal, Dominican National Baseball Hero; Natasha Despotovic, GFDD Executive Director; Guillermo Sención, Dominican Businessman; Roberto Cavada, journalist; Jimmy Sierra, Dominican filmmaker; Yvette Marichal, Director of DGCINE, and Omar de la Cruz, director of the Dominican Global Film Festival. # Bringing Attention to Violence Against Women with a Screening of the Film "Un acto de rebeldía"

In commemoration of the International Day for the Elimination of Violence Against Women, GFDD/Funglode held a free screening of the film *Un acto de rebeldía al día* (A Rebellious Act a Day) at the GFDD offices in Washington, DC. The audience of several dozen enjoyed

the eight-minute-long film, one of a series of short stories aimed at bringing the issue of violence against women to the public agenda in the Dominican Republic. After the screening, the producer of the film, Nicole Coiscou, explained the movie aims to empower Dominican women by demonstrating daily actions that help to combat machista culture. A series of panel discussions followed that featured international experts on gender and gender-related violence in Latin America and the Caribbean, including Hilary Anderson, Senior Gender Specialist at the OAS. Anderson and the other panelists argued that, although some progress has been made, much work remains, both in a cultural and policy sense, for the region to improve security and prosperity for women and girls. At the closing of the event, GFDD Executive Director Natasha Despotovic thanked the special guests, panelists and audience members for their participation and stressed GFDD's continued commitment to raising awareness of gender issues throughout Latin America and the Caribbean.

#### December 12, Lawrence, Massachusetts




## Launch of "Dominican Cultural Dictionary" Author Jimmy Sierra
